These are interesting and challenging times. The COVID-19 Delta Virus is in New Zealand and we are all facing major restrictions and changes in our daily lives.

It is fortunate the virus hasn't made its way here. We can control how we respond and perhaps the best tool we have against COVID-19 is vaccination. You can now book online to have your vaccinations in Kawerau or phone the Eastern Bay 0800 829 001 number.

At Council, our staff are working and available to assist you. We thank you for your support and patience.

Along with our daily business operations, we are working our way through the Government's proposed Three Waters Reform. Under the reform model, Kawerau's drinking water, wastewater and stormwater assets would be part of Entity B with 22 other Councils from the wider Waikato, Bay of Plenty, Taupo and Taranaki regions.

We have now received the independent review of the Three Waters Reform proposal from international consultants, Castalia.

On Tuesday, we held a workshop with Councillors and staff to discuss the initial findings.

We have always said we would share this independent review with the Kawerau community and give residents an opportunity to have their say. The review from Castalia and the report from Tühura Partners, the governmentfunded agency that is assisting the Department of Internal Affairs are both available on our Council website. We had intended to run a formal consultation process later this year, but it is timely to ask for feedback now.

Gathering your feedback now means we can add any issues and concerns you raise into our report back to the Government at the end of September. The Government advises that we are not expected to make any decisions about opting in or opting out at this stage.

It is important to note, that if change is warranted and the outcomes stand up to scrutiny we would always support it, whether it is a reform or a change of practices.

We also continue to collaborate with other Councils in the proposed Entity B region, many of whom are doing their own evaluations with external consultants.

Finally, I wish to acknowledge the passing of former Mayor Lyn Hartley recently. COMMUNITY GRANTS APPLICATION EXTENDED

Applications to the Kawerau Community Grants scheme have been extended due to the COVID-19 lockdowns.

The Community Grant Scheme is a Council fund to enhance the well-being of Kawerau people by supporting groups and/or services that improve the quality of life of local residents.

Council allocates approximately \$19,000 per year to this fund. Successful applicants are eligible for up to \$3,000 per application.

The Community Grants Committee will delay their meeting.

The Scheme is available to any non-profit group that provides a service which enhances the quality of life of Kawerau residents.

RATES PAYMENT EXTENSION

For people who usually pay their rates in the Council Offices we have extended the payment date until 5pm Friday, 24 September.

Even under COVID-19 Level 2 – people can book and receive their COVID-19 vaccinations in Kawerau.

Kawerau and Eastern Bay residents can book their vaccinations by phoning 0800 829 001.

Vaccinations in Kawerau occur at Firmin Lodge in Waterhouse Street on Monday and Tuesday - but they must be booked and strict Level 2 conditions are in place.

Remember everyone aged 12 and over is eligible for the COVID-19 vaccination which is free.

COUNCIL VENUES LEVEL 2

THREE WATERS REFORM - COUNCIL ASKS FOR **YOUR FEEDBACK**

In July 2020, the Government launched the Three Waters Reform programme.

Currently 67 different councils own and operate the majority of the drinking water, wastewater and stormwater services across New Zealand. The intention is that four entities will manage the drinking water, wastewater and stormwater in New Zealand and benefit from scale and operational efficiencies.

We encourage you to become well informed about the Three Waters Reform proposal from all parties.

Kawerau District Council has now received the independent review of the Three Waters Reform proposal from international consultants Castalia (available on Council's website)

Q. Will the Kawerau Council District and Residents be better off under Three Waters Reform?

A. The DIA funded Tūhura Partners "Balanced Scorecard" suggests no. Castalia's review suggests that the (WICS) modeling is so flawed that it is not possible to answer this question.

Q. Are there significant risks to Council should Council decide to opt out of the Three Waters **Reform programme?**

A. Castalia's evaluations indicate risks should Council join the reform and recommends Kawerau puts a constructive counter-proposal to government.

Kawerau has been asked to submit a report to the government's Department Internal Affairs (DIA) with any amalgamation issues and concerns by the end of September.

We want to gather feedback from the community and add it into our report back to the government.

Council is not expected to make any decisions now whether to opt in or opt out of the reform.

SOME OF THE CONCERNS ALREADY RAISED INCLUDE:

- · The modelling being taken from the Water Commission for Scotland and comparing that to New Zealand, and specifically to Kawerau.
- The data and assumptions used in the analysis by the Government's Department of Internal Affairs (DIA) funded Tühura Partners.
- Having influence over local decisions.
- Effective representation on Entity B with the proposed • six Council representatives and six Iwi leaders.
- Ensuring the forecast savings for ratepayers are realistic and can be delivered.
- · Ensuring the water assets are protected against privatisation.
- Ensuring that Council's strategic planning is taken into consideration.
- That our Three Waters Council staff and Three Waters local contracting businesses have ongoing involvement in the delivery of Three Waters services.
