No person shall keep, or cause to be kept, or have in his/her care three dogs of a greater age than three months unless a kennel licence has been obtained from the Council permitting three dogs to be kept

CONDITIONS RELATING TO THE ISSUE OF LICENCE

- The number of dogs on the premises shall NOT exceed the number permitted as indicated on the licence. 1
- 2. All dogs kept on the premises must be housed in such a manner as not to cause a nuisance to neighbours or any person.
- 3. Kennels, runs and other areas on the property used by the dogs must be kept clean and free from nuisance
- All requirements of the Kawerau District Council Dog Control Bylaw and the Dog Control Act 1996 and subsequent 4. amendments must be met.
- All deaths, sales or transfers of dogs, (including pups born on the premises) are to be notified to Council within 14 5. days.
- 6. A licence may be subject to such terms, conditions and restrictions as Council may from time to time consider necessary to impose.
- 7. A licence may be revoked if there is any breach of its conditions.
